**Application Note** BOVINE IgG F(ab¹)2 fragment Texas Red™ conjugated is designed for immunofluorescence microscopy.

This product was prepared from normal serum by delipidation, salt fractionation, ion exchange chromatography followed by pepsin digestion and extensive dialysis against the buffer stated above. Assay by **Purity And Specificity** 

immunoeléctrophoresis resulted in a single precipitin arc against anti-Bovine IgG, anti-Bovine IgG F(ab')2 and

anti-Bovine Serum. No reaction was observed against anti-Bovine IgG F(c) or anti-Pepsin.
