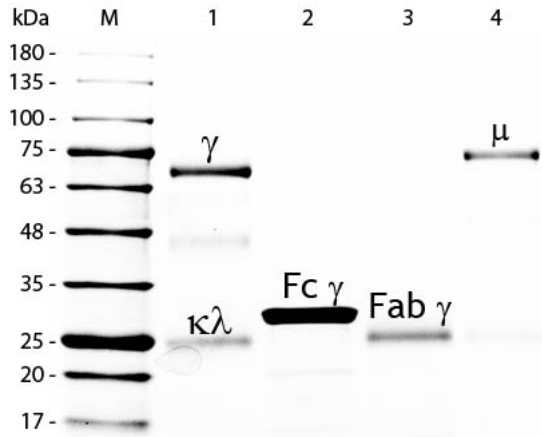

<b>Buffer</b>	0.02 M Potassium Phosphate, 0.15 M Sodium Chloride, pH 7.2
<b>Reconstitution Volume</b>	1.0 mL
<b>Reconstitution Buffer</b>	Restore with deionized water (or equivalent)
<b>Stabilizer</b>	10 mg/mL Bovine Serum Albumin (BSA) - Immunoglobulin and Protease free
<b>Preservative</b>	0.01% (w/v) Gentamicin Sulfate. Do NOT add Sodium Azide!
<b>Storage Condition</b>	Store vial at 4° C prior to restoration. For extended storage aliquot contents and freeze at -20° C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4° C as an undiluted liquid. Dilute only prior to immediate use.
<b>Synonyms</b>	Chicken IgG F(c) fragment peroxidase conjugated, Chicken IgG F(c) fragment HRP conjugated
<b>Application Note</b>	Chicken IgG F(c) fragment peroxidase conjugated is designed for immunofluorescence microscopy, fluorescence based plate assays (FLISA) and fluorescent western blotting. This product is also suitable for multiplex analysis, including multicolor imaging, utilizing various commercial platforms.
<b>Background</b>	Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their destruction or neutralization via agglutination (and thereby immobilizing them), activation of the complement cascade, and opsinization for phagocytosis. This antibody possesses the F(c) region, recognized by high-affinity Fc receptor proteins.
<b>Purity And Specificity</b>	This product was prepared from normal serum by delipidation, salt fractionation, ion exchange chromatography followed by papain digestion and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Chicken IgG, anti-Chicken IgG F(c) and anti-Chicken Serum. No reaction was observed against anti-Chicken IgG F(ab') <sub>2</sub> or anti-Papain.
