Horse IgG Fab Texas Red™ is designed for immunofluorescence microscopy, fluorescence based plate assays **Application Note** 

(FLISA) and fluorescent western blotting. This product is also suitable for multiplex analysis, including multicolor imaging, utilizing various commercial platforms.

Secreted as part of the adaptive immune response by plasma B cells, immunoglobulin G constitutes 75% of serum immunoglobulins. Immunoglobulin G binds to viruses, bacteria, as well as fungi and facilitates their **Background** 

destruction or neutralization via agglutination (and thereby immobilizing them), activation of the compliment cascade, and opsinization for phagocytosis. This product possesses the F(ab) region possessing the epitoperecognition site, both heavy and light chains of the antibody molecule are present.

This product was prepared from normal serum by delipidation, salt fractionation, ion exchange chromatography followed by papain digestion and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Horse IgG, anti-Horse IgG F(ab')2 and Purity And Specificity

anti-Horse Serum. No reaction was observed against anti-Horse IgG F(c) or anti-Papain.
