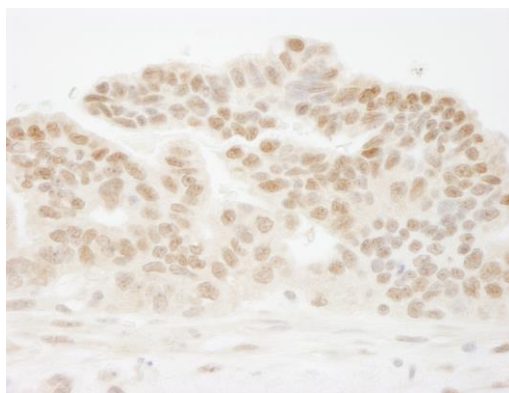

PRODUCTION PROCEDURES	Antibody was affinity purified using an epitope specific to CSTF50 immobilized on solid support. The epitope recognized by IHC-00248 maps to a region between residue 75 and 125 of human cleavage stimulation factor, 3' pre-RNA, subunit 1, 50kDa using the numbering given in entry NP_001315.1 (GeneID 1477). Antibody concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG.
APPLICATIONS	Centrifuge tube to remove product from lid. Optimal working dilutions should be determined experimentally by the investigator. Prepare working dilution immediately before use. Immunohistochemistry 1:100 - 1:500
APPLICATION NOTES	Epitope exposure is recommended. Epitope exposure with citrate buffer will enhance staining. Likely to work with frozen sections.
IHC HUMAN CONTROLS	In some cases, the antibody may be diluted further than indicated. Bladder Cell Carcinoma, Ovarian Carcinoma, Prostate Carcinoma
